# Single view fleet status

CashXCell mobile app sustains Merchant real-time awareness by staying constantly in touch, while away of his computer. CashXCell mobile application maintains direct contact with the CMN System, anytime, anywhere.

Entities list provides a single view status of each Cash Smart Safe device in your fleet. Quickly identifying occasional issues marked by time-stamped colored icons with short status description. In large installed base of Smart Safes, there are provisions to show only devices in error, and/or search by smart filters.

### Dashboard view

Select any Smart Safe by a simple touch, to bring its Dashboard view with current cash inventory, shift operator, last few days runtime series of daily cash turnover, and much more.

### Shifts perpetual history details


Drill down to operational shifts by date and/or by supervisor, with information on associated cash deposits. Traverse back perpetually in time by scrolling down.

# **Entity Dashboard to monitor cash**






# **Health monitoring notifications**

CashXCell allows you to provide your preferred settings:



Settings, among other, affect the health monitoring of your Cash Smart Safes fleet. You may define the monitoring frequency, whether it will happen only while WiFi is available or even by using cellular telephony comms, and profile the means of notification by defining the ringtone, vibration and LED alarm.




# **Cashiers Shifts history**
